## Registration Requirements

### Vehicle Registration

All vehicles in Singapore must be registered with the Land Transport Authority (LTA).

### Eligibility Criteria

Cars manufactured before 1 January 1940 are vintage cars and can be imported for registration in Singapore under the Vintage Vehicle Schemes.

If a car was deregistered in Singapore while under the Vintage Vehicle Scheme, it cannot be re-registered as a vintage car.

Eligible cars that were previously deregistered in Singapore can be re-imported for re-registration under the Vintage Vehicle Schemes. Once it is registered as a vintage car, you cannot change the ownership of the car for 5 years.

### Scheme Available

You can register your vintage car under the Vintage (Normal) Vehicle Scheme or Revised Vintage Vehicle Scheme. Details of these Schemes are given in **Annex A**.

## Technical Requirements

### Compliance with Road Traffic Act and its Subsidiary Legislations

All vintage cars to be registered in Singapore must be maintained in roadworthy condition and meet the Road Traffic (Motor Vehicles, Construction and Use) Rules and Road Traffic (Motor Vehicles, Lighting) Rules.

### Modifications to Vehicle

The vintage car should be restored to its original state. There should not be any alterations, conversions or modifications to the car before import. No kit car such as a replica or a car rebuilt with old or new parts is allowed.

### Concessions

The following concessions are given to vintage cars:

- a) They need not meet exhaust emission requirements, as vintage cars are unlikely to meet modern requirements;
- b) Where the technical specifications of a vintage car are unable to meet regulatory requirements fully, other concessions may be granted on a case-by-case basis if safety is not affected; and
- c) Left-hand drive cars may be registered.

## Step-by-Step Guide to Import a Vintage Car in Singapore

### Step 1

Check if your vintage car meets registration and technical requirements.

### Step 2

Ship the vintage car to Singapore through a shipping agent.

### Step 3

Arrange with your shipping agent to obtain an **Inward Cargo Clearance Permit**. Your agent will have to submit an application to the Singapore Customs using the TradeNet® System. **Permit and processing fee, Excise Duty and Goods & Services Tax (GST)** will be payable to the Singapore Customs through inter-bank GIRO. The Singapore Customs determines the Customs Value [or commonly known as Open Market Value (OMV)] of the vintage car by taking into account the purchase price, freight, insurance, handling and all other incidental charges to the sale and delivery of the vintage car in Singapore. Excise Duty will be levied at 20% of the OMV. GST is computed at 9% of the total Cost, Insurance & Freight (CIF) and Excise Duty. The following documents may be required to be submitted to the Singapore Customs for assessment purposes:

- a) Original Manufacturer/Purchase Invoice;
- b) Freight and Insurance Papers;
- c) Bills/receipts relating to other incidental charges;
- d) Original foreign vehicle registration documents;
- e) Letter from a competent authority confirming the date of manufacture of the vintage car (if the vehicle registration documents do not state such information); and
- f) Application for exemption from payment of excise duty (if applicable).

All documents submitted **MUST** be in the English language. Notarised translations are acceptable. For further information on the determination of OMV for vehicles, please visit [www.customs.gov.sg](http://www.customs.gov.sg) or contact the Singapore Customs.

### Step 4

Prepare documents for verification and registration of the vintage car in Singapore. Please refer to the Step-by-Step Guide to Register a Vintage Car in Singapore below.

## Step-by-Step Guide to Register a Vintage Car in Singapore

### Step 1

Decide whether you want to register the vintage car yourself or through a motor dealer to register the vintage car for you. If a motor dealer registers the vintage car on your behalf, they will carry out all or most of the following steps for you.

### Step 2

You must submit an application for vehicle approval to LTA through the Vehicle Inspection and Type Approval System (VITAS). You need to pay an application fee of \$274.68.

Please refer to VITAS website (<https://vrl.lta.gov.sg/certlogin.html>) for more details on opening a user account and application procedures. If you do not have a registered account, you can make an appointment via our Digital Services (<https://www.lta-eappointment.sg>, select Vehicle Approval > Apply for Vehicle Approval Code) to submit your application to LTA, Vehicle Approval & Control Division, 10 Sin Ming Drive, Singapore 575701.

Documents to be submitted for verification include:

- a) Original Manufacturer/Purchase Invoice;
- b) Freight and Insurance Papers;
- c) Bills/receipts relating to other incidental charges;
- d) Original foreign vehicle registration documents;
- e) Letter from a competent authority confirming the date of manufacture of the vintage car (if the vehicle registration documents do not state such information);
- f) Detailed technical specifications of the vintage car; and
- g) Inward Cargo Clearance Permit;

All documents submitted **MUST** be in the English language. Notarised translations are acceptable.

Once in-principle approval has been given, you will be notified to send the vintage car for inspection at any LTA-Authorised Inspection Centres (see **Annex B**) where an inspection fee will be charged.

After your vintage car has passed the inspection, an approval letter with a Vehicle Approval Code (VAC) will be issued to you. With this VAC, you may proceed to register the vintage car.

**Step 3**

Once all information and documents are in order, you can make an appointment via our Digital Services (<https://www.lta-eappointment.sg>, select Registration > Register Vehicles (Self-Import)) to submit the following documents to LTA, Vehicle Quota & Registration Division, 10 Sin Ming Drive, Singapore 575701 for registration:

- a) Application for Registration and Licensing of a Motor Vehicle (Form R01). Refer to “Forms” at <https://onemotoring.lta.gov.sg> for the latest form;
- b) Identification documents of the vehicle owner:
  - For individual owners
    - Original<sup>1</sup> NRIC [for Singaporeans and Permanent Residents (PRs)] or Employment/Immigration pass card<sup>2</sup> (for foreigners).
  - For companies
    - Printout of the business profile of the company from the Accounting & Corporate Regulatory Authority (ACRA). This printout is valid up to 14 days from the date of issue;
    - Original<sup>1</sup> NRIC (for Singaporeans and PRs) or Employment/Immigration pass card<sup>2</sup> (for foreigners) of the authorised person from the company; and
    - Original authorisation letter, signed by at least a Manager or above, if the authorised person of the company is not listed in the ACRA printout.
  - For organisations
    - A copy of certificate issued by the Registry of Societies or relevant regulating authority; and
    - Original<sup>1</sup> NRIC (for Singaporeans and PRs) or Employment/Immigration pass card<sup>2</sup> (for foreigners) of the authorised person from the organisation.
- c) Approval letter with VAC;
- d) Valid Motor Insurance Cover, covering the full licensing period (i.e. from registration date to 31 December of the same calendar year);
- e) Notice of Retained/Bid Vehicle Registration Number (if any);
- f) Notice of Preferential Additional Registration Fee (PARF)/COE rebates (if any); and
- g) Inward Cargo Clearance Permit.

Total fees payable by NETS or SGQR PayNow:

### Vintage (Normal) Vehicle Scheme

- a) Processing Fee of \$28.34 per application (if registration is done at LTA's office);
- b) Registration Fee of \$350;
- c) Additional Registration Fee (ARF), which is calculated as follows<sup>3</sup>:

For Vintage (Normal – Transferrable) cars registered with COEs obtained before the second COE bidding exercise in February 2023

Vehicle OMV	ARF Rate
First \$20,000	100%
Next \$30,000 (i.e. \$20,001 to \$50,000)	140%
Next \$30,000 (i.e. \$50,001 to \$80,000)	180%
Above \$80,000 (i.e. \$80,001 and above)	220%

Example:

The ARF payable for a Vintage (Normal – Transferrable) car with an OMV of \$100,000 will be calculated as follows:

Vehicle OMV (\$100,000)	ARF Rate	ARF Payable
First \$20,000	100%	100% x \$20,000 = <b>\$20,000</b>
Next \$30,000	140%	140% x \$30,000 = <b>\$42,000</b>
Next \$30,000	180%	180% x \$30,000 = <b>\$54,000</b>
Above \$80,000	220%	220% x \$20,000 = <b>\$44,000</b>

Total ARF payable is (\$20,000 + \$42,000 + \$54,000 + \$44,000) = **\$160,000**

For Vintage (Normal – Transferrable) cars registered with COEs obtained from the second COE bidding exercise in February 2023 onwards

Vehicle OMV	ARF Rate
First \$20,000	100%
Next \$20,000 (i.e. \$20,001 to \$40,000)	140%
Next \$20,000 (i.e. \$40,001 to \$60,000)	190%
Next \$20,000 (i.e. \$60,001 to \$80,000)	250%
Above \$80,000 (i.e. \$80,001 and above)	320%

<sup>3</sup> ARF may be waived if the ownership of the Vintage (Normal) car is not changed.

Example:

The ARF payable for a Vintage (Normal – Transferrable) car with an OMV of \$100,000 will be calculated as follows:

Vehicle OMV (\$100,000)	ARF Rate	ARF Payable
First \$20,000	100%	100% x \$20,000 = <b>\$20,000</b>
Next \$20,000	140%	140% x \$20,000 = <b>\$28,000</b>
Next \$20,000	190%	190% x \$20,000 = <b>\$38,000</b>
Next \$20,000	250%	250% x \$20,000 = <b>\$50,000</b>
Above \$80,000	320%	320% x \$20,000 = <b>\$64,000</b>

Total ARF payable is (\$20,000 + \$28,000 + \$38,000 + \$50,000 + \$64,000) = **\$200,000**;

- d) Secure a Certificate of Entitlement (COE) in the appropriate vehicle category. Cars are classified under Category A or Category B:

<b>Category A</b>	<p><u>For COEs obtained before the May 2022 first COE bidding exercise:</u> Cars with engine capacity up to 1,600cc <u>and</u> Maximum Power Output up to 97kW (130bhp)</p> <p><u>For COEs obtained from the May 2022 first COE bidding exercise onwards:</u> Car, except fully electric car, with engine capacity up to 1,600cc and Maximum Power Output up to 97kW (130bhp); and fully electric car with Maximum Power Output up to 110kW (147bhp)</p>
<b>Category B</b>	<p><u>For COEs obtained before the May 2022 first COE bidding exercise:</u> Cars with engine capacity above 1,600cc <u>or</u> Maximum Power Output above 97kW (130bhp)</p> <p><u>For COEs obtained from the May 2022 first COE bidding exercise onwards:</u> Car, except fully electric car, with engine capacity above 1,600cc or Maximum Power Output above 97kW (130bhp); and fully electric car with Maximum Power Output above 110kW (147bhp)</p>

Alternatively, you can secure a COE under the Open Category (i.e. Category E).

There are 2 COE bidding exercises each month. The bidding exercises usually start on the first Monday and third Monday of the month at 12pm and last for 3 working days. The exercises will usually end on the Wednesday in the same week at 4pm.

You can submit your COE bid, enquire on the bid status and revise your reserve price through the following channels:

You must have a bank account with the participating banks in order to bid. You can submit the bid by indicating your reserve price, i.e. the maximum amount you are willing to pay for your COE. The minimum reserve price is \$1 and the amount of bid must be in multiples of \$1. Bid submitted cannot be withdrawn or revised downwards.

A fixed deposit of \$10,000 will be deducted from your bank account upon submission of the bid application. There will be an administration fee charged for each bid application and for every subsequent revision.

You can check the current COE information on the ONE.MOTORING website (<https://onemotoring.lta.gov.sg>) or on the MyTransport.SG Mobile App (download the App "MyTransport Singapore" via the Apple App Store or Google Play).

#### Points to note:

- Unless you are representing a company or organisation, each applicant is permitted only one bid in each bidding exercise.
- COEs in Categories A and B are non-transferable. They are valid for 6 months. Hence, you must use the COE to register your car within 6 months.
- COEs in Category E are transferable once only if the COE is bid under the name of an individual. Category E COEs bid in the name of company and business (including limited liability partnership, club, association, etc.) are not transferable. Category E COEs are valid for 3 months. Hence, you must use the COE to register your car within 3 months.



- Category E TCOE can be used to register any vehicle type (Category E TCOE obtained from May 2017 bidding exercises onwards can no longer be used to register motorcycle/scooter). However, when the vehicle is subsequently deregistered, the COE Rebate granted to the last registered owner would be based on the Quota Premium (QP) of either Category E or its corresponding Category from the same tender exercise, whichever is lower.
  - At the time of registration, a COE of 10 years will be issued to the vehicle.
  - At the time of registration, the difference between the QP and your COE bid deposit is payable. If your deposit is more than the QP, the difference will be used to offset the ARF and Registration Fee payable to register your vehicle.
  - If you are not successful in your bid for a COE, the bid deposit will be automatically refunded to your bank account one working day after the announcement of the bidding results. You may try bidding again in the next COE bidding exercise; and
- e) Road Tax  
Similar to a normal car. It is calculated as pay per use, including weekends and public holidays.  
Refer to <https://onemotoring.lta.gov.sg> for the latest road tax rate under “Buying”, “Upfront Vehicle Costs”, “Vehicle Tax Structure”.

### Revised Vintage Vehicle Scheme

- a) Processing Fee of \$28.34 per application (if registration is done at LTA’s office);
- b) Registration Fee of \$350;
- c) ARF, which is calculated at 10% of the OMV;
- d) COE, which is calculated at 10% of the Prevailing Quota Premium (PQP) in the appropriate vehicle category applicable at the time of registration:

<b>Category A</b>	<p><u>For COEs obtained before the May 2022 first COE bidding exercise:</u> Cars with engine capacity up to 1,600cc <u>and</u> Maximum Power Output up to 97kW (130bhp)</p> <p><u>For COEs obtained from the May 2022 first COE bidding exercise onwards:</u> Car, except fully electric car, with engine capacity up to 1,600cc and Maximum Power Output up to 97kW (130bhp); and fully electric car with Maximum Power Output up to 110kW (147bhp)</p>
<b>Category B</b>	<p><u>For COEs obtained before the May 2022 first COE bidding exercise:</u> Cars with engine capacity above 1,600cc <u>or</u> Maximum Power Output above 97kW (130bhp)</p> <p><u>For COEs obtained from the May 2022 first COE bidding exercise onwards:</u> Car, except fully electric car, with engine capacity above 1,600cc or Maximum Power Output above 97kW (130bhp); and fully electric car with Maximum Power Output above 110kW (147bhp)</p>

- e) Road Tax of up to 45 days in a calendar year, including weekends and public holidays, first 28 Day Licences at \$10 per licence and 17 additional Day Licences at \$20 per licence.

**Step 4**

Collect the following from LTA, Vehicle Quota & Registration Division, 10 Sin Ming Drive, Singapore 575701 upon registration of the vintage car:

- a) Notification of registration;
- b) Receipt; and
- c) Paper Day Licences (pro-rated from registration date to 31 December of the same calendar year).

**Step 5**

Upon successful registration, a vehicle registration number will be assigned to the vintage car, unless a retained or bid vehicle registration number is used. You have to affix the vehicle registration number plates on your car, and then seal<sup>4</sup> them at any LTA-Authorised Inspection Centres within 7 days of registration. The vehicle registration number plates for a car under the Vintage (Normal) Vehicle Scheme will be the same as normal car (i.e. white lettering on a black background). The vehicle registration number plates for a car under the Revised Vintage Vehicle Scheme will be with white lettering on a red and yellow background.

## Usage Restrictions

### Vintage (Normal) Vehicle Scheme

There are no usage restrictions for cars under the Vintage (Normal) Vehicle Scheme and you are not required to display a Day Licence.

### Revised Vintage Vehicle Scheme

You can only use your vintage cars for 45 days in a calendar year under the Revised Vintage Vehicle Scheme, including weekends and public holidays. You must display a valid Day Licence each time you use it. You can buy up to 45 Day Licences (first 28 Day Licences at \$10 per licence and 17 additional Day Licences at \$20 per licence) at LTA, Vehicle Licensing Division, 10 Sin Ming Drive, Singapore 575701.

If your revised vintage car is registered after 1 January and the number of remaining days of the calendar year is less than 45 days, the number of Day Licences you are allowed to buy will be capped to the number of remaining days (e.g. if your revised vintage car is registered on 1 December, you can buy up to 28 Day Licences at \$10 per licence and 3 Day Licences at \$20 per licence).

Day Licences cannot be transferred to another vehicle, exchanged nor refunded. Day Licences cannot be carried over to another calendar year.

## Conditions

Vintage cars cannot be converted to other vehicle schemes, such as normal car or revised off-peak car schemes.

Vintage cars cannot be laid-up.

A vintage car pays ERP and must have an In-Vehicle Unit (IU) installed (see **Annex C**).

The vehicle registration number plate of your revised vintage car must be sealed at any LTA-Authorised Inspection Centres. You must apply to LTA for approval before breaking the vehicle registration number plate seal for repairs or carrying out other works on your revised vintage car.

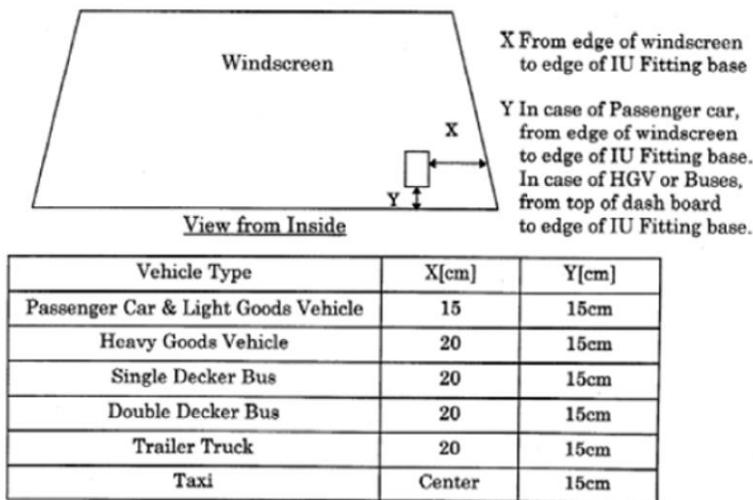

**Annex C**

**Standard In-Vehicle Unit (IU) Fitting Position Requirements**

The following figure illustrates the standard IU fitting positions for the various vehicle types:



- The area of the glass windscreen which the IU is mounted on (□ in diagram), must not be of a material or content that affects the communications (radio frequency) between the IU and the ERP facility or equipment.
- The □ surface area must be at least 78mm x 121mm in the vertical orientation.
- For any request for the □ surface area to be at the bottom centre of the windscreen, this would warrant testing at a designated ERP test facility in Singapore (such testing is required to demonstrate that there is no communications failure from fitting the IU at that position).
