TERMS & CONDITIONS

Pre-requisites

The following requirements must be met before submission of the application for conversion:

- Motor insurance coverage requirements
- Other requirements as LTA may notify, e.g. settlement of outstanding offences in respect of the vehicle

Documents To Be Produced For Application

- Original certificate for motor insurance, covering at least the remainder of the calendar year upon conversion to all Vintage Car Schemes, except to Vintage (Normal) Scheme. For vehicles under Vintage (Normal) Scheme, the motor insurance should cover not less than the full period of valid
- Original^A NRIC (Singaporeans and Singapore PRs) or Employment/Immigration Pass Card# (Foreigners) for individual owner. If the owner is a company or business, please produce the original ACRA printout valid up to 14 days from the date of issue and the original^ NRIC (Singaporeans and Singapore PRs) or Employment/Immigration Pass Card# (Foreigners) of the authorised person from the company or business
- Original NRIC (Singaporeans and Singapore PRs) or Employment/Immigration Pass Card (Foreigners) of submitter if the registered owner is not present at the time of application

Changing Of Vehicle Registration Number Plates

Upon conversion of the vehicle to the Revised Vintage Scheme, the registered owner shall proceed to change the number plates, within 3 calendar days from the conversion date. The number plates must have white letters/figures on red and yellow background. The existing vehicle registration number will be retained. The front number plate must be mounted to a metal bracket and the bracket must in turn be welded onto the vehicle chassis or floorboard. The welding may be carried out by any workshop but must be inspected and approved by an LTA-authorised vehicle inspection centre. Failure to comply with the registration number plate requirement constitutes an offence under the Road Traffic Act. Sealing / Breaking Of Vehicle Registration Number Plates

- To seal the number plates of vehicle registered under the Vintage (Restricted) Scheme or Revised Vintage Scheme vehicle, the owner must send the vehicle to an LTA-authorised vehicle inspection centre (i.e. VICOM Ltd, STA Inspection Pte Ltd or JIC Inspection Services Pte Ltd). An inspection certificate will be issued to the owner after the number plates are sealed and inspected.
- If the owner wishes to break the vehicle's number plate seals for repair or other works on the vehicle, he/she must first apply to LTA for approval. Any person not authorised by the Registrar of Vehicles and who breaks or tampers with the vehicle number plate seal shall be liable, upon conviction, to a jail term of up to 3 months, or to a fine of up to \$1,000 for the first offence. Subsequent offences carry a jail term of up to 6 months, or a fine of up to \$2,000.

- <u>Day Licence for Vintage (Restricted) Scheme & Revised Vintage Scheme Vehicles</u>
 (a) Vintage (Restricted) Scheme Up to 28 days in the same calendar year @ \$10 per day.
- Revised Vintage Scheme Up to 28 days in the same calendar year @ \$10 per day; and (b)
 - Up to 17 additional days in the same calendar year @ \$20 per day.

A valid Day Licence must be displayed for each day of usage in respect of any Vintage (Restricted) Scheme vehicle or Revised Vintage Scheme vehicle. Days of usage are inclusive of weekends and public holidays.

Day Licences are non-transferable, non-exchangeable, non-refundable and cannot be carried forward to another calendar year. It is a serious offence for anyone to use a Vintage (Restricted) Scheme vehicle or Revised Vintage Scheme vehicle without displaying a valid Day Licence. The driver or registered owner who causes or permits the vehicle to be driven without a valid Day Licence shall be guilty of an offence and shall, on conviction, be punished with a fine of not exceeding \$5,000, and in the case of second or subsequent conviction, a fine of not exceeding \$10,000.

In-Vehicle Unit

A vintage vehicle is required to have a valid In-Vehicle Unit (IU) installed and a cashcard with sufficient monetary value inserted into the IU if the vehicle is to be used on an Electronic Road Pricing (ERP)-priced road during the ERP operational hours.

Consent for Collection, Use and Disclosure of Personal Data

You consent to us collecting from/and or disclosing to any other Government agency or public authority, and/or using, your personally identifiable data, including those that you have provided in this application, so as to serve you in an efficient and effective way.
